President's report: (Paula Lavallee)

Quarterly DignityUSA phone call: Mark Matson gave an update on what the various chapters were doing for presiders: Though a wide range of people from different backgrounds were being utilized as presiders by Dignity chapters, most appeared to be led by lay-ordered priests (i.e. Dominican or Jesuit) in dioceses where the bishop has refused church services on its own premises such as ours

Liturgy Committee: (Denise Arceneaux)

Philip Knowles will not be able to preside in October. Paula L. will preside should we not get anyone else.

OLD BUSINESS:

- The 35th Anniversary Party/Dance: 16 people paid for the dinner so far. Someone donated \$100.00. Delia V. suggested using this for a "scholarship." We need 40 people to attend to meet our minimum requirements for occupancy. D.J.: Music will be provided by Delia and others. National Board Member present? Leo will be the representative from the National Board to speak since Marianne Duddy-Burke can not come. She may tape a video of herself and send it to us. Otherwise, she will send a letter. Decorations: The decorations will be provided by the restaurant.
- Verbena: Money set aside for Verbena: There was a suggestion that ½ of it go to the Pride Foundation with a note for it to address Women's health issues and ½ of it be used to send someone to the Convention in July. The final decision on where to send the money, however, was held off until Mike Linden calls the Pride Foundation and asks what amount of the money goes to the Administration itself and what goes to the 3rd party. The Board is still open to suggestions from the membership as to where the money should go.

- Jim Rankin will give up his job of picking up the mail from the P.O. Box. Time sensitive statements can be done electronically—such as those for the phone and SGN. Delia V. will arrange for electronic statements to be received from both the phone and SGN. Jim will still send out the newsletters and will set up for the social after church but someone needs to help him carry the items downstairs.
