Catholics Mobilizing to Preserve Washington's Newly Enacted Marriage Equality Law

Catholics "in the pews" at parishes throughout the Archdiocese, engaging in informal coordination with Catholic PFLAG (Parents and Friends of Lesbians and Gays) members and Call To Action—Western Washington are considering various actions to emphasize the fact that a supermajority of Washington Catholics (an estimated 65% or more) strongly support the recently enacted gay/lesbian marriage equality law passed by the Washington State Legislature and signed by Governor Christine Gregoire.

It is likely that a referendum to overturn the law will collect enough signatures to appear on the November ballot. It is equally likely that Washington State voters will become the first in the nation to uphold marriage equality in a statewide vote. However, we cannot be complacent in the face of strong Catholic hierarchical opposition and hundreds of thousands of out-of-state anti-marriage equality dollars that are expected to flow into the state.

A Political Action Committee (PAC) called "Catholics for Marriage Equality Washington State" (CFMEWA) was formed in late March. Among ideas floating around are putting in large, signed ads in daily newspapers; marching in the Pride Parade; letter-writing campaigns; and engaging grassroots Catholics in parishes.

- Volunteer Opportunities: 10 people worked at Food Lifeline the last time.
- 2015 Convention: The National Board accepted the recommendation to have the Convention at the Renaissance. In the next few months we need to give input to the National Committee for the theme and the logo though it's up to National to come up with one. We need to think about doing promotional things at the 2013 Convention for the 2015 Convention like giving away something which acknowledges the city. The 2015 Convention will be held on the 4th of July Weekend.
- Picnic: The Seattle Parks and Recreation accepted our first choice of Saturday, August 4 at 3 PM to again occupy Woodland Park Shelter #7 for the annual summer picnic. Delia mailed an \$80 check to Seattle Parks and Recreation as full payment for the use of the shelter.
